Shaily Engineering Plastics Limited, 366, At & PO: Rania, Taluka: Savli, District: Vadodara- 391780 has applied for conversion of their existing DTA unit into EOU under 100% EOU scheme 366, At & PO: Rania, Taluka: Savli, District: Vadodara- 391780 for manufacturing of Injection Mould Plastics Components, Injection Mould for Plastics. The nature of the applicant firm is **Public Limited Company.**
