

Minutes of the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> Meeting (2018 Series) of the Units Approval Committee (UAC) for monitoring of performance of EOUs held on 03.01.2018 at 11:00 Hrs. at Central Excise Bhavan, Ahmedabad, under the Chairpersonship of Shri Rajesh Kumar, Jt. Development Commissioner(i/c), KASEZ

**Monitoring of performance of 100% EOUs:**

Monitoring of performance of 100% EOUs falling under the jurisdiction of following commissionerates for the period 2016-17 was taken up for review as per the Para 6.20 of FTP, 2015-20 read with Para 6.12 of HBOP, Performance of EOUs shall be monitored by UAC as per guidelines given in Appendix- 6F.

1. Ahmedabad-I Commissionerate. (Now Ahmedabad-South Commissionerate)
2. Ahmedabad-II Commissionerate. (Now Ahmedabad-North Commissionerate)
3. Ahmedabad-III Commissionerate. (Now Gandhinagar Commissionerate)

The Asstt. Commissioner, Ahmedabad-South has informed that after re-organization of the Commissionerates under GST regime Ahmedabad\_I, II and III commissionerate are now called Ahmedabad-South, Ahmedabad-North and Gandhinagar Commissionerate.

It was decided that each commissionerate may send a list of EOUs falling under their jurisdiction to DC office for reconciliation.

**(a) Ahmedabad-South Commissionerate**


It was noted that at present there are 08 working units, 07 units have achieved positive NFE and following unit had not submitted its APR for the year 2016-17. It was informed by JDC (i/c); SCN will be issued to the units.

The committee also noted that following EOUs had foreign exchange unrealized as on 31.03.2017 beyond permissible period.

It was also noted that M/s. Meghmani Dyes and Intermediates Ltd has been exited from 100% EOU scheme. It was informed by JDC (i/c) that letter will be issued to the unit to submit documentary proof such as e-BRC etc. If not furnished SCNs will be issued to the unit concerned as per provision of para 2.54 of FTP 2015-2020.





**(b) Ahmedabad- North Commissionerate**

It was noted that at present there are 28 working units, 23 units have achieved positive NFE while one unit **M/s. Lucent Clean Energy Pvt. Ltd** and following unit had not submitted its APR for the year 2016-17. It was informed by JDC (i/c); SCN will be issued to the units for non-submission of APRs and for non-achieving Positive NFE.

**(c) Ahmedabad- Gandhinagar Commissionerate**

It was noted that at present there are 17 working units, 15 units have achieved positive NFE and following unit had not submitted its APR for the year 2016-17. It was informed by JDC (i/c); SCN will be issued to the units for non-submission of APR.


Shri D.C. Mehta of Koswein India and Shri Jayaprakash M., Production Manager of M/s. Gujarat Microwax Pvt. Ltd. attended the meeting and stated that they are facing some issues after implementation of GST such as clearance of DTA, payment of duty, dates of State and Central GST, Refund of IGST, Regional Language etc.

The Jt. Development Commissioner(i/c) requested them to make a reference to office of the Development Commissioner, KASEZ so the issue could be properly examined in consultation with Central Excise Authority.

20 Unit holders have attended the meeting and stated that they do not have any other problem with DC office and they have achieved positive NFE.

Joint Development Commissioner(i/c), Kandla SEZ mentioned that many of EOUs don't have Input-Output norms duly ratified by a Norms Committee (NC) in DGFT which is necessary if their products that are not covered under SION or if wastage is not less than 2% ( in terms of value & quantity both). Such units should make serious efforts to get input-output norms fixed/ratified from Norms Committee concerned in DGFT; continuation of ad-hoc permission from DC' Office will not suffice and ultimately norms are to be fixed by NC concerned. He requested representative of Central Excise also to look into this aspect, as central excise has day to day interaction with the units
