

Minutes of the 21<sup>st</sup> Meeting (2018 Series) of the Units Approval Committee (UAC) for EOUs for monitoring of performance of EOUs held on 22.10.2018 at 16:00 hrs for the year 2017-18, at Seminar Room, 1<sup>st</sup> Floor, CGST Bhavan, Ahmedabd, under the Chairmanship of Shri Rajesh Kumar, Deputy Development Commissioner, KASEZ

Following were present:

The Deputy Development Commissioner, KASEZ, welcomed all the Officers and there was a brief introduction of all.

### **Monitoring of Performance of 100% EOUs**

Monitoring of performance of 100% EOUs falling under the jurisdiction of **Ahmedabad-South, Ahmedabad-North and Gandhinagar Commissionerate** for the period 2017-18 was taken up for review as per the Para 6.20 of FTP, 2015-20 read with Para 6.12 of HBOP, Performance of EOUs shall be monitored by UAC as per guidelines given in Appendix - 6F.

The Superintendent, Customs Division, Paldi informed that after introduction of GST and consequent reorganisation of commissionerates, now working of EOUs is looked after by different EP-Circles of Customs formation and he requested for a list of EOUs falling under Ahmedabad jurisdiction. The same has been provided in the meeting.

#### **(a) Ahmedabad-South Commissionerate**

It was noted that at present there are 09 working units out of which 07 units have achieved Positive NFE and one unit as mentioned below has not submitted its APR for the year 2017-18, even after letter requesting for submission was issued to all such units. Hence, it was decided by the committee that SCN may be issued to all such units who have not submitted their APR's.

The committee also noted that M/s Compact Softech Pvt. Ltd. has submitted APR which is not certified by C.A. for the year 2017-18. However, a letter requesting to submit it C.A. certified copy has also written to the unit but till date unit has not



submitted C.A. certified APR. Hence, committee has decided to issue SCN to the said unit for non submission of APR for the year 2017-18.

The committee also noted that M/s Advantage Healthcare have no activity in the year 2017-18. It was decided by DDC to ask the said unit in writing as to the reasons for non activity.

**(b) Ahmedabad-North Commissionerate**

It was noted that at present there are 27 working units out of which 20 units have achieved Positive NFE and following units have not submitted their APR for the year 2017-18, even after letter requesting for submission was issued to all such units. Hence, it was decided by the committee that SCN may be issued to such all units who have not submitted their APR's.

The committee also noted that M/s Bitscape IT Solution Pvt. Ltd. have no activity in the year 2017-18. It was decided by DDC to ask the said unit in writing as to the reasons for non activity.

The committee also noted that following EOUs had foreign exchange/export proceeds unrealized as on 31.03.2018 beyond permissible time period.

It was directed by DDC that letter will be issued to the unit to submit documentary proof such as e-BRC etc. If not furnished SCN will be issued to the unit concerned as per provisions of para 2.54 of FTP 2015-2020.

The committee noted that M/s Emcure Pharmaceuticals Limited have negative NFE in the year 2017-18. It was informed by DDC that the unit is in the first year of first block period of their commercial production. Hence, unit may be kept under watch category and decided to write a letter for the same.





**(c) Gandhinagar Commissionerate**

It was noted that at present there are 17 working units out of which 14 units have achieved Positive NFE and one unit as mentioned below had not submitted its APR for the year 2017-18 even after letter requesting for submission was issued to the unit. Hence, it was decided by the committee that SCN may be issued to all such units who have not submitted their APR's.

The committee also noted that M/s Gujarat Agri Product Exports Co. and M/s Kadam Exports Pvt. Ltd. have no activity in the year 2017-18. It was informed by DDC; both the units have applied for de-bonding, therefore, procedure for final de-bonding may be completed.

The committee also noted that following EOUs had foreign exchange unrealized/export proceeds unrealized as on 31.03.2018 beyond permissible time period.

It was directed by DDC that letter will be issued to the unit to submit documentary proof such as e-BRC etc. If not furnished SCN will be issued to the unit concerned as per provisions of para 2.54 of FTP 2015-2020.

2. Mr. Benoi Antony representative of M/s Skaps Industries (I) Pvt. Ltd., Ahmedabad had informed that they faced many problems in getting GST refund. The Superintendent of EP circle told them that now GST refund of IGST has been process through Port, Airport and ICD, and officer has been deputed for IGST refund issues. If there is any problem of any unit they may approach to specified officer deputed for IGST refund at Port, Airport and ICD.

3. Deputy Development Commissioner, Kandla SEZ has noticed that all units has not updated their official e-mail ID and contact number which causes inconvenience for communicating while seeking information from the units for expeditious communication to MOC. Hence, he advised to all unit representatives to update the same.



4. Deputy Development Commissioner, Kandla SEZ has informed unit representatives to fill all columns of APR before submission to DC office, particularly pending export proceeds and revenue contribution etc.

5. Deputy Development Commissioner, Kandla SEZ has explained about the rules and procedures of extension/renewal of LOP, Broadbanding, Addendum, DTA sale permission, Standard Input Output Norms and Star Status certificate. He also explained about the required documents for the same.
