

Minutes of the 22<sup>nd</sup> Meeting (2018 Series) of the Units Approval Committee (UAC) for EOUs for monitoring of performance of EOUs held on 23.10.2018 at 11:30 hrs for the year 2017-18, at conference Room, 1<sup>st</sup> Floor, GST Bhavan, Vadodara, under the Chairmanship of Shri Rajesh Kumar, Deputy Development Commissioner, KASEZ

The Deputy Development Commissioner, KASEZ, welcomed all the Officers and there was a brief introduction of all.

### **Monitoring of Performance of 100% EOUs**

Monitoring of performance of 100% EOUs falling under the jurisdiction of **Vadodara-I, Vadodara-II, Anand and Bharuch** for the period 2017-18 was taken up for review as per the Para 6.20 of FTP, 2015-20 read with Para 6.12 of HBOP, Performance of EOUs shall be monitored by UAC as per guidelines given in Appendix - 6F.

The Superintendent, EP Circle-3, Vadodara has informed that after introduction of GST and consequent reorganisation of Commissionerates, now working of EOUs is looked after by different EP-Circles of Customs formation and he requested for a list of EOUs falling under Vadodara jurisdiction. The same has been provided in the meeting.

#### **(a) Vadodara-I Commissionerate**

It was noted that at present there are 24 working units out of which 19 units have achieved Positive NFE and following units as mentioned below has not submitted their APR for the year 2017-18, even after letter requesting for submission was issued to all such units. Hence, it was decided by the committee that SCN may be issued to all such units who have not submitted their APR's.

**(a) Vadodar-II commissionerate**

It was noted that at present there are 13 working units out of which 08 units have achieved Positive NFE and following units as mentioned below has not submitted their APR for the year 2017-18, even after letter requesting for submission was issued to all such units. Hence, it was decided by the committee that SCN may be issued to such all units who have not submitted their APR's in prescribed time period.

**(b) Vadodara Commissionerate(Anand)**

The Monitoring Committee monitored NFE Status of the units for the year 2017-18 and it was noted that at present there are 6 working units and all the units have achieved positive NFE.

The committee also noted that following EOUs had foreign exchange unrealized/export proceeds unrealized as on 31.03.2018 beyond permissible time period.

**(a) Vadodara Commissionerate(Bharuch)**

2. Mr. Jignesh Parikh representative of M/s Shaily Engineering Plastics, Ahmedabad had informed that they faced many problems in getting GST refund. The Superintendent of EP circle told them that now GST refund of IGST has been process through Port, Airport and ICD, and officer has been deputed for IGST refund issues. If there is any problem of any unit they may approach to specified officer deputed for IGST refund at Port, Airport and ICD.

3. The representative of M/s Geetanjali Wollens Pvt. Ltd. and M/s Prayas Wollens Pvt. Ltd. had informed that their LOP will expire on 30.11.2018 on this DDC had replied to them their request for the same had sent to BOA.

4. Deputy Development Commissioner, Kandla SEZ has noticed that all units was not updated their official e-mail ID and contact number which causes inconvenience



for communicating while seeking information from the units for expeditious communication to MOC. Hence, he advised to all unit representatives to update the same.

5. Deputy Development Commissioner, Kandla SEZ has informed unit representatives to fill all columns of APR before submission to DC office, particularly pending export proceeds and revenue contribution etc.

6. Deputy Development Commissioner, Kandla SEZ has explained about the rules and procedures of extension/renewal of LOP, Broadbanding, Addendum, DTA sale permission, Standard Input Output Norms and Star Status certificate. He also explained about the required documents for the same.
