

Minutes of the 23rd Meeting (2018 Series) of the Units Approval Committee (UAC) for EOUs for monitoring of performance of EOUs held on 24.10.2018 at 11:30 hrs for the year 2017-18, at Seminar Room, Diamond Park SEZ, Surat, under the Chairmanship of Shri Rajesh Kumar, Deputy Development Commissioner, KASEZ

The Deputy Development Commissioner, KASEZ, welcomed all the Officers and there was a brief introduction of all.

Monitoring of Performance of 100% EOUs

Monitoring of performance of 100% EOUs falling under the jurisdiction of **Surat Commissionerate** for the period 2017-18 was taken up for review as per the Para 6.20 of FTP, 2015-20 read with Para 6.12 of HBOP, Performance of EOUs shall be monitored by UAC as per guidelines given in Appendix - 6F.

It was noted that at present there are 04 working units out of which 03 units have achieved Positive NFE and one unit M/s Motan Enterprise have not submitted its APR for the year 2017-18.

The Deputy Development Commissioner, KASEZ has informed the committee that M/s Motan Enterprise has a case which was adjudicated by the Central Excise Commissionerate(GST) and against the Order-in-Original party had filed an appeal before CESTAT. Further, the unit has submitted request for shift/transfer from 100% EOU Scheme to SEZ unit, however, request of unit was examined as per para 6.38 of HOBP 2015-20 that an EOU may be shifted to SEZ with approval of the Development Commissioner provided EOU has achieved pro-rata obligation under EOU scheme but no compliance has received from the unit.

2. Mr. Ankit Maheshwari, Director of M/s Kothari Infotech (P) Ltd. had informed that they are developing software and export the same in CD with dongle. Further, they informed that they want to export the software through online but they get problem in foreign exchange from RBI as of now there is no such mechanism with the RBI for the same. The Deputy Development Commissioner, KASEZ told him that they represent their matter to the RBI and copy the same to DC office and this office also pursues the same to the RBI.



3. Deputy Development Commissioner, Kandla SEZ has noticed that all units has not updated their official e-mail ID and contact number which causes inconvenience for communicating while seeking information from the units for expeditious communication to MOC. Hence, he advised to all unit representatives to update the same.

4. Deputy Development Commissioner, Kandla SEZ has informed unit representatives to fill all columns of APR before submission to DC office, particularly pending export proceeds and revenue contribution etc.

5. Deputy Development Commissioner, Kandla SEZ has explained about the rules and procedures of extension/renewal of LOP, Broadbanding, Addendum, DTA sale permission, Standard Input Output Norms and Star Status Certificate also explained about the required documents for the same.
