Kandla SEZ Authority, Government of India, Ministry of Commerce & Industry, having responsibility of development of Kandla Special Economic Zne, invites bids from Licenced/Authorized Security Service Providers for supply of following personnel for 8 hours duty, six days a week:-

(a) Security Guards

- 32 Nos.

(b) Gunmen

- 08 Nos.

(c) Firemen

- 07 Nos.

- 1. The service provider should have experience of successfully completed works during the last 3 years ending last day of the month previous to the one in which applications are invited.
- 2. The service provider should have completed three similar works (atleast one of them should be in Central Govt./Central Autonomous Bodies/Central Public Sector Undertakings/reputed Corporations in the private sector) costing not less than the amount equal to 25% of estimate cost put to tender,

OR

Two similar completed works, each costing not less than the amount equal to 50% of the estimated cost put to tender

OR

One similar completed work of aggregate cost not less than the amount equal to 80% of the estimated cost

3. The personnel are proposed to be hired for an initial period of two years with a provision of extending it for two more years at the discretion of the Chairman, Kandla SEZ Authority.



- 4. The educational qualification of security personnel should be minimum class 10th pass.
- 5. The height of the Security personnel shall not be less than 5.5" and should be of sound health.
- 6. The personnel should have at-least one year experience of security work.
- 7. The bidder shall submit the bio-data of gunmen/security guards/Firmen with full details i.e. name of the person, full residential address, qualification, experience along with 2 recent photos and shall also submit the Police verification of these security personnel at the time of actual deployment to the Security Officer, Kandla SEZ.
- 8. The bidder's Annual Turnover should not be less than Rs.1.00 crore during any of the financial year 2015-16, 2016-17 & 2017-18. In this regard, CA certified accounts for three years shall be provided.
- 9. In case the work of any of the personnel is not found to be satisfactory, the same would be conveyed in writing and the service provider shall not deploy him and shall provide a replacement.
- 10. The personnel will be deployed in three shifts as per requirement.
- 11. Each bid shall be accompanied by a demand draft of Rs.1,00,000/- (Rupees one lakh only) towards earnest money deposit, payable in favour of "Kandla SEZ Authority", payable at Gandhidham without which the bid will not be considered valid.
- 12. While bidding, the bidder should submit two sealed envelopes separately super-scribed as "Technical Bid" and "Financial Bid". No conditions should be added to the tender.

(i) Technical Bid:

The Technical Bid should be as per Annexure-A. It should be supported by the documents indicated in the said Annexure. The Demand Draft/Banker's cheque in respect of the Earnest Money Deposit should be submitted with the "Technical Bid".

(ii) Financial Bid:

The "Financial Bid" should be as per Annexure-B.

- 13. Initially only the "Technical Bids" will be opened. The "Financial Bids" will be opened, only if, the bidder fulfills the stipulated conditions of Technical Bid.
- 14. The bids should reach this office on or before 1300 hours on 20th August, 2018. Bids received thereafter will not be considered. No acknowledgement, in respect of receipt of any bid, shall be issued. The bid can be dropped in Tender Box placed near reception of office of Development Commissioner, Kandla SEZ.
- 15. The technical bids will be opened on 20/08/2018 at 1600 hrs. in the Conference Hall of Kandla Special Economic Zone Administrative Office building. Bidders who wish to attend may remain present at their discretion.



- 16. The bid should not be filled in with pencil. Such bids will be rejected. Each page of the bid should be signed by the authorized signatory/owner/Managing Director of the Agency. There should not be any overwriting/striking out, etc.
- 17. The Chairman, Kandla SEZ Authority, reserves all rights to reject any one or all tenders.
- 18. On getting intimation from KASEZ Authority, the successful bidder shall execute an agreement as per Annexure-C and furnish a bank guarantee or FDR from a scheduled bank equivalent to 10% of the total amount of the contract as Performance Security Deposit within 15 days of award of contract. The Bank Guarantee/FDR shall be valid for a period of 24 months, which will be extendable as per the requirement of Kandla SEZ Authority. This will be released only after successful completion of the contract and also meeting the condition at Sr.No.23. EMD, however, will be returned on receipt of the performance security deposit.
- 19. A declaration from the bidder as per Annexure-D that they are not blacklisted by any Central/State Government/Public Undertaking/organizations the bidder has previously provided security services to.
- 20. In case of non-compliance of the terms and conditions of the contract, a penalty may be levied on the basis of certificate signed by the Security Officer. The penalty for some of the defaults are as under:-

1	Late Reporting	Rs.100/- per day
2	Non reporting	Rs.250/- per day
3	Refusal of duties	Rs.250/- per day
4	Non-observation of dress-code	Rs.100/- per day
5	Change of security guards without prior permission	Rs.500/- per day

- 21. The bidder shall be responsible for complying with all statutory requirements for providing its personnel with requisite facilities such as payment of minimum wages as per Govt.'s Minimum Wages Act, liability of weekly rest and leave, etc.
- 22. Since the persons engaged by the service provider shall be employees of the service provider, it shall be his/her duty to pay their wages every month and the service provider is responsible for all statutory payments/obligations. In so far as statutory deduction from wages of security personnel like PF and ESIC are concerned, the service provider shall provide proof of deposit of the same with concerned Govt. authorities.
- 23. The performance security deposit shall be released after submission of proof of deposit of PF, ESIC and NOC from Labour Commissioner and Kandla SEZ Authority.
- 24. Bidder shall ensure daily attendance of above said number of security personnel/gunmen/firemen for 8 hours duty and also responsible for providing accommodation, transport, etc. as may be required and shall provide replacement of security personnel on leave or absent for any reason immediately.
- 25. KASEZ Authority may at any time have increased requirement upto 50%.



- 26. Service provider shall furnish a medical fitness in respect of all the personnel deployed, duly certified by a Registered medical practitioner.
- 27. Service provider shall ensure that the personnel deployed are not below the age of 18 years and not above the age of 58 years.
- 28. The employees deployed in Kandla SEZ Shall not have any right to claim employment under Kandla SEZ Authority. The service provider shall indemnify and keep indemnified Kandla SEZ Authority against such claims, if any.
- 29. The service provider shall be responsible for any injury to its personnel. Furthermore, the service provider shall not claim any damage or compensation or reimbursement of any expense which has been incurred by them in compensating the persons employed by them and that necessary insurance cover will be taken by them in respect of any accident, injury or death in the course of performance of duty by any person deployed by them. In the event of any employee deployed by the service provider making any claim against Kandla SEZ Authority in relation to death or personal injury sustained by any person, then, the service provider shall undertake to effectively indemnify and keep Kandla SEZ Authority indemnified against any such claims. This clause shall be applicable till the expiry and/or premature termination of the Agreement. The total liability of Kandla SEZ Authority under the Agreement under any circumstances shall not exceed the amount actually due and payable to the service provider as per the monthly charges for security personnel mentioned above for the services actually provided.
- 30. The Service Provider/Service Provider's personnel shall not divulge or disclose to any person any details of this office, operational process, technical know-how, security arrangements and administrative/organizational matters.
- 31. In case the service provider fails to perform or its performance is found to be unsatisfactory, the contract will be terminated by the Chairperson, KASEZ Authority giving one month's notice and the performance guarantee in that case shall be forfeited without assigning any reason. No termination compensation or any other amount shall be payable by the Kandla SEZ Authority.
- 32. There should be regular and proper checking of the performance of the personnel by the service provider.
- 33. KASEZ Authority will not pay any other charges.
- 34. The successful bidder shall provide name, address, e-mail ID & telephone number of his local representative who can be contacted any time in case of any requirement.

35. KASEZ Authority will have right to cancel posting of any security person/personnel without assigning any reason.
