Dear Sir,

It is requested to provide the following information under the RTI Act, 2005:

As per proviso (1) to Section 3 of Gujarat Stamp Act, any instrument executed or on behalf of, or in favour of the Government, in cases where, but for this exemption, the Government would be liable to pay the stamp duty chargeable in respect of such instruments, stamp duty shall be waived on such instruments.

I would like to know under the RTI Act 2005, whether the sub-lease agreements executed between the Kandla SEZ Authority and the Units located in Kandla SEZ for allotment of space in the SEZ qualify for stamp duty waiver at the time of registration of sub-lease agreement, under the above quoted provisions.
