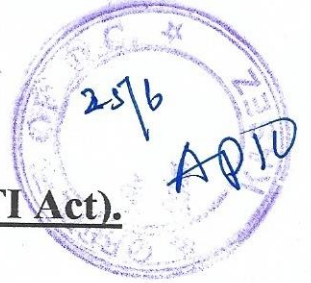

2. It is suspected that the earlier gang of solar battery thieves has again been re-activated. The names of suspected thieves who are resident of Kidana village are as under:-

Copper/Aluminum/Steel Scrap Theft - The under mentioned thieves of Kidana village are suspected to be actively involved in the theft of Copper/Aluminum/Steel Scrap inside the KASEZ processing area. They are usually active during night and many times they were chased by our custom Security but they run away. They are always equipped with Knife and Dhariya:-

1. I want to bring in your kind notice regarding the incidence of following theft cases occurred in KASEZ during last ten days:-


