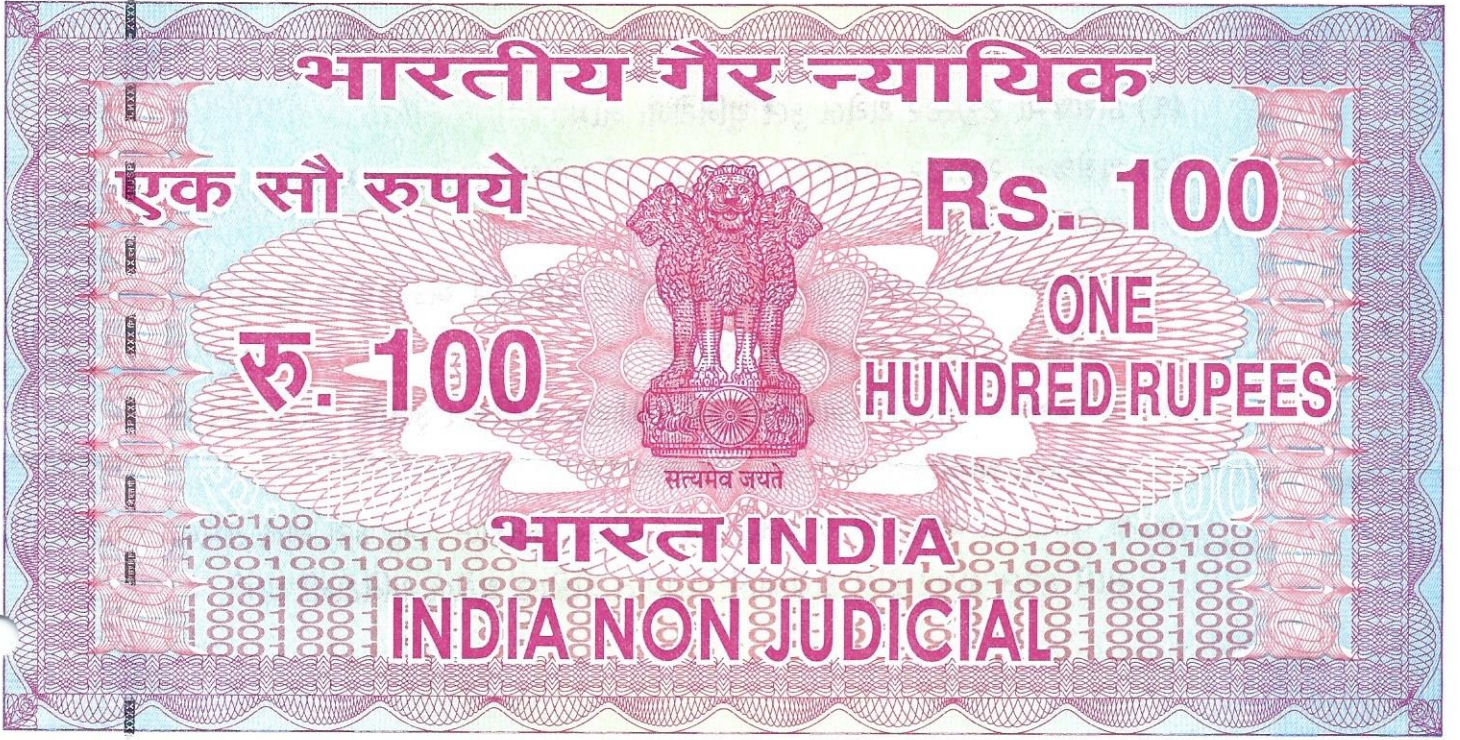



1. Total number of units in Kandla Special Economic Zone is already uploaded and available in website [KASES.gov.in](http://KASES.gov.in) under category "Kandla SEZ working unit list 2018-19" which is in public domain.
2. Total number of used clothing units in KASEZ is 17, the details of the same is being enclosed **as Annexure- "A"**.
- 3, 4 & 5- As per SEZ Act, 2005 and SEZ Rules, 2006, the units in SEZs are required to achieve positive Net Foreign Exchange as per formula given in Rule 53 of the SEZ Rules, 2006 and only in September, 2018, a new Rule 18 (4B)(c) of SEZ Rules, 2006 was inserted wherein the used clothing units in SEZ were required to fulfill their export obligations in addition to meeting their Net Foreign Exchange obligation and all such units shall be required to ensure certain minimum percentage of the unit annual turnover is physically exported out of the country.
