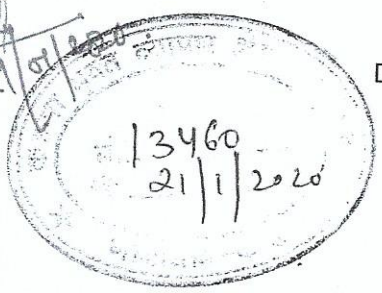

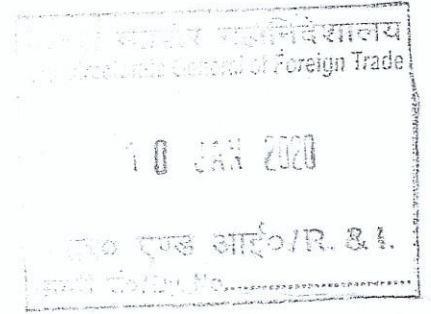

In this regard, as per information received from concerned branches/sections, it is informed that the information sought pertains to DGFT and does not pertain to this office, as the applicant has sought information on the cases regarding non-achievement of physical export orders issued by DC, KASEZ pertaining to worn clothing units and plastic recycling units and quantity exceeding orders passed by DC, KASEZ pertaining to plastic recycling units pending before DGFT. Both the worn clothing units and plastic recycling units have filed appeals before DGFT against the orders passed by DC, KASEZ and the said appeals are pending before DGFT.
