A brief detail of the proposal is as under:-

- The FOB value of export for said project for 05 (five) years period is projected as Rs. 7733.12 lakhs, with foreign exchange outgo NIL, resulting in NFE of Rs. 7733.12 lakhs (100.00%).
- The Developer, GIDC vide letter dated 30-06-2018 has earmarked, & confirmed allotment of Plot No. 43 & 46 in the SEZ for the proposed project.

The observations as proposed by the Approval Committee are as under:-

1. Mr. G.C. Daxini, Additional Commissioner, Income Tax (Exemption), nominee of Commissioner of Income Tax, informed that some demand against the Directors of the said company is pending. Therefore, committee is of the view that compliance on the same should be obtained from the unit and LOA should be issued after submission of compliance by respective Directors and confirmation thereof by the Income Tax Authorities.
2. The proposed manufacturing product i.e. Dental Cotton Rolls technically fall under pharmaceutical products but committee is of the view that the product "Dental Cotton Roll" is made up of the raw material viz. Cotton according to the manufacturing process flow chart submitted to the committee. Although, the product's end use is pharmaceutical, but actually the product falls under Medical Textile category and accordingly committee has granted approval for setting up of unit for manufacturing of Dental Cotton Roll in the Sector Specific SEZ for Textiles & Textile Articles at Ahmedabad Apparel Park SEZ.

Therefore, Approval Committee after due diligence and deliberation approved the project, subject to standard terms and conditions of the SEZ Rules, 2006.
