Approved minutes of the previous meeting were confirmed by the Approval Committee.


35-A-01 Request of M/s. Artex Apparels for inclusion of “Additional Items” of manufacturing in the present Letter of Approval (LOA) issued vide F.No. KASEZ/P&C/for settin6/43/2007-08 dated 06.08.2007 valid upto 11/01.2020.

Shri Abhay B. Shah, Director of the applicant firm M/s. Artex Apparels, appeared before the Approval Committee for personal interview. He mentioned that at present the company is holding LoA to manufacture “Readymade Garments.” He stated that the company at present is already exporting ready-made garments with the annual capacity of 12 lakhs pieces and wants to expand its production capacity by inclusion of items namely, “*cut pieces of fabrics*” with annual capacity of 1 lakh pieces of 6 lakh meters and “*clothing bags*” with annual capacity of 50,000 units. He submitted that the present unit has all the requisite infrastructure related to land and building, plant and machinery and electrification, and need not any further investment in the said project. Thus it will result in more capacity utilization of the unit. It will help the company in additional Forex Revenue generation and also better utilization of the resources.

On being asked about the details of the project, the Director explained that initially the fabric in the form of roll, especially denims, will be procured directly from the mills, and after completion of the specified tasks like pressing, printing, embroidery, washing, stitching, biding, double binding, etc., it will be cut into pieces of length 6-8 meters and will be exported. There is a good demand of the cut pieces in foreign countries, especially US and Europe. The denims, in rolls, may be procured domestically or imported as required.

The UAC categorically permitted the import of denim rolls, but import of readymade or stitched garment or any worn garments in any form will not be permitted.

After scrutiny of the agenda and discussion, the Approval Committee concluded and approved the said proposal of M/s Artex Apparels and also gave their consent for issuance of Letter of Approval for the said proposal, subject to submission of the undertaking that there is no dues pending regarding Income Tax/ Customs/ CGST/ Central Excise/ Service Tax & they will not import any RMG or stitch cloths in any form.
