
**Subject: - Request for Letter of Approval (LOA) for setting up of a second new unit by M/s. Worldwide Safety (P) Ltd. in GIDC Ahmedabad Apparel Park SEZ, Khokhra**

Shri Prashant Tulsyan, Director and Shri Sandeep Kakkar, Deputy Director, M/s Worldwide Safety (P) Ltd. along with their consultant Shri R R Dave, appeared to represent the case of the unit. They introduced the details of the products to the Approval Committee and shown the samples of the products being manufactured at the present set in AAP-SEZ, Ahmedabad unit, to the Approval Committee. They also showed samples of the raw materials either being procured from domestic market or imported from overseas suppliers to the Approval Committee. They informed that the products are mainly used for safety of the persons working in Automobile industry as well as other heavy industries which are prone to the accidents like cutting of the human body parts etc. while handling heavy metal parts.


The Approval Committee discussed in length about the products for manufacture and export of items as mentioned below:

1. ***Knitted Gloves (HSN Code: - 61169300)***
2. ***Knitted Gloves covered with plastic (HSN Code: - 61161000)***
3. ***Synthetic knitted dipped gloves (HSN Code: - 61161000)***
4. ***Synthetic knitted sleeves (HSN Code: - 61178090)***

The Approval Committee under the chairmanship of the Zonal Development Commissioner, Shri Amiya Chandra, asked to confirm whether any of the items proposed to import are covered under the provision of anti-dumping duty or safeguards duty, to which the party submitted that as on date there is no such item as per the existing provisions. The Approval Committee asked to submit an undertaking for the same. The Joint Commissioner of Income Tax, also asked for the affidavit regarding non pendency of any Income Tax demands. The Deputy Commissioner of CGST, Ahmedabad South also asked to submit an affidavit regarding non pendency of any CGST/Service Tax/Excise/ Customs demands before the issuance of the LoA.



The Approval Committee agreed upon and approved the said proposal for setting up of a new Unit by M/s. Worldwide Safety (P) Ltd, subject to submission of the above mentioned declaration and affidavit by the Unit.
