**CASE-43-A-01**

Request by M/s Tarasafe International Pvt. Ltd. for inclusion of "Additional Items" of manufacturing in the present Letter of Approval (LOA) issued vide F.No. KASEZ/DCO/AAP-SEZ/II/01/2010-11/160-161 dated 03.06.2010 valid till 14/07/2022.

Shri Dipak Mistry, Manager/s Tarasafe International Pvt. Ltd. appeared in the personal interview before the Approval Committee. The Development Commissioner on behalf of the Approval Committee enquired about DTA sale made by the Unit, subsequent to the conditional approval (subject to ex-post-facto approval of UAC) for broad-banding granted on 19/5/2020, in respect of the request by their Unit. The General Manager replied that no DTA sales have been made till date as they cannot get raw material fabric from the DTA market, as it is not allowed in terms of the prohibition for export imposed by the DGFT notification for the specific product. The Development Commissioner asked if they can import from China for DTA sale, the unit representative had no idea about it. The Unit representative also failed to submit any specific business plan ahead.

Therefore, the Approval Committee cancelled and withdrawn the **conditional broadbanding approval** issued to the said unit on 19/5/2020 and asked the Unit Representative to come with a specific business plan before the Approval Committee for approval of the broad banding.
