**29-A-01) Request of M/s. Prithvi Hitex Creations Pvt. Ltd., AAP-SEZ, for broad-banding of Letter of Approval (LOA) for inclusion of new items for manufacture and export:-**

Shri Mahaveer Kankaria, Director of the applicant company – M/s. Prithvi Hitex Creations Pvt. Ltd., AAP-SEZ, appeared before the Committee for personal interview and explained the proposal for broad-banding to include additional/new items i.e. textiles and textile articles for manufacture and export to the existing LOA.

The Approval Committee was given to understand that the Government of India, in the Ministry of Commerce, vide letter No. D.12/45/2009-SEZ, dated 13-09-2013, with subject "Implementation of the SEZ (Amendment) Rules, 2013 – clarifications regarding" interalia, in Para-6 of the said letter clarified/defined sectoral broad-banding provisions for categories of sectors encompass similar/related area with each broad-band sector treated as a single sector, viz. 'Textile, apparel, hosiery, fashion garments, wool and carpet'.

Shri Mahaveer Kankaria, Director of the applicant company – M/s. Prithvi Hitex Creations Pvt. Ltd., AAP-SEZ was asked to tell the manufacturing process of the different items which are to be included in their LOA (i.e. Annexure-II). Shri Mahaveer Kankaria explained about the manufacturing process in detail. Shri Mahaveer Kankaria was asked to submit the Flow Chart of their manufacturing process of the items annexed as Annexure-II and he promised to submit the same shortly.

In view of the broader clarification of the Government of India on the aspect of sectoral broad-banding and the explanations given by Shri Mahaveer Kankaria, Director of the applicant company – M/s. Prithvi Hitex Creations Pvt. Ltd., AAP-SEZ, the Approval Committee after due diligence and deliberation approved the proposal of M/s. Prithvi Hitex Creations Pvt. Ltd., AAP-SEZ for broad-banding of the existing LOA to include new items as per Annexure-II and as per application dated 16-08-2017, subject to standard terms and conditions, of the SEZ Rules, 2006.
