Sub:- Precaution to be taken by Kandla SEZ Units in view of “Tauktae” Cyclone – Reg.


As you are aware a severe cyclone “Tauktae” has developed in the Arabian Sea and is expected to make land fall in Kutch shortly. Therefore, all the units in the Zone are hereby advised that an action plan must be kept ready for addressing emergency situation, which may arise due to the cyclone at the same time taking care of the COVID protocol.

2. A copy of the guidelines issued by the Deputy Director, Industrial Safety and Health, Adipur is attached herewith which should be scrupulously followed by all the units in Kandla SEZ.

3. The cyclone is expected to reach Kutch between 17th and 18th May, 2021. In view of the above, all the units in KASEZ are hereby directed to take necessary measures for safety of men and material employed in their units and take precautions as detailed in the guidelines issued by the Deputy Director, Industrial Safety and Health, Adipur without fail.

4. Also, it is directed that all units in KASEZ shall remain closed from 6.00 pm today till 6.00 pm on 18th May, 2021. In case the units involve continuous process or manufacture of essential items as defined in the guidelines issued by the Ministry of Home Affairs, New Delhi from time to time the same shall be allowed to function with bare minimum staff. All the units operating under essential category/ continuous process category shall submit a declaration as per Annexure to this Circular via email on: cyclone.kasez@gmail.com

Dy. Director Industrial Safety and Health, Adipur Kutch.

1. Inflammable cargo and chemicals stored in the liquid storage tanks must be kept at minimum quantity, so to avoid accidents,
2. Water logging over the liquid storage tanks needs to be avoided and if any roof is found to have leakage, same must be repaired.
3. Roof of the sheds where hazardous cargo is stored should be made leakage proof.
4. All the units must have their emergency plan for evacuation of the workers, if the need arises and make their workers aware of the same. Also fire fighting equipment should be kept ready and manpower should be trained to use the same.
5. In case of any repairing works are being carried out at the roofs of the building, same must be stopped. Only in case of emergency, repairing may be carried out using safety belt and net under proper supervision.
6. Labours should be evacuated from the temporary housing facilities to the safer locations,
7. Drains in the factory premises must be cleaned.
8. Recharge well should be cleaned.
9. Drain pipes from the roofs of the building must be cleaned.
10. De-watering pumps must be kept ready and repaired.
11. Earthing pits must be checked for their consistency and must be kept fit,
12. All the electrical connections must be checked and if any of the connections is found loose, same must be repaired. Use IS standard electrical connections/switches.
13. Welding works must be stopped and electrical cables should be routed over the ground instead of the on the ground where water would be logged.
14. ELCB/MCB/RCCB must be checked for any defects and be kept in working condition.
15. Antidote must be kept in stock for addressing hazard of the dangerous cargo.
16. Board or hording placed at the top of the factory/buildings/higher places must be placed down.
17. Lighting arrester's earthing must be checked and be kept in working condition
18. Workers health must be checked and monitored.
19. Onsite emergency plan must be kept ready and necessary rehearsals be carried out.
